### Professional Support & Wellbeing (PSW)

Professional Support & Wellbeing (PSW) within NIMDTA is available to all trainees at any time during the training year. The PSW is separate from regulatory processes such as ARCP panels, GDC or GMC investigations.

### NIMDTA Study Day Programme

As a DCT you will receive approximately 10 NIMDTA study days. Study sessions include some hands-on training. These sessions are planned and run by NIMDTA. Mentoring and Research sessions are available during the training year alongside a five-day MFDS Study Aid programme.

### Simulation Training

NIMDTA house ten Dental Simulation units available for use during the DCT training year. This highly advanced haptic simulation equipment offers dental training in a Virtual Reality (VR) environment. DCTs can experience procedures on simulated 3D models with highly realistic haptic feedback provided.

### DCT Salary

Health and Social Care is a devolved responsibility and as such salaries for health and social care staff in Northern Ireland are set out in Pay Circulars issued by the Department of Health (NI).

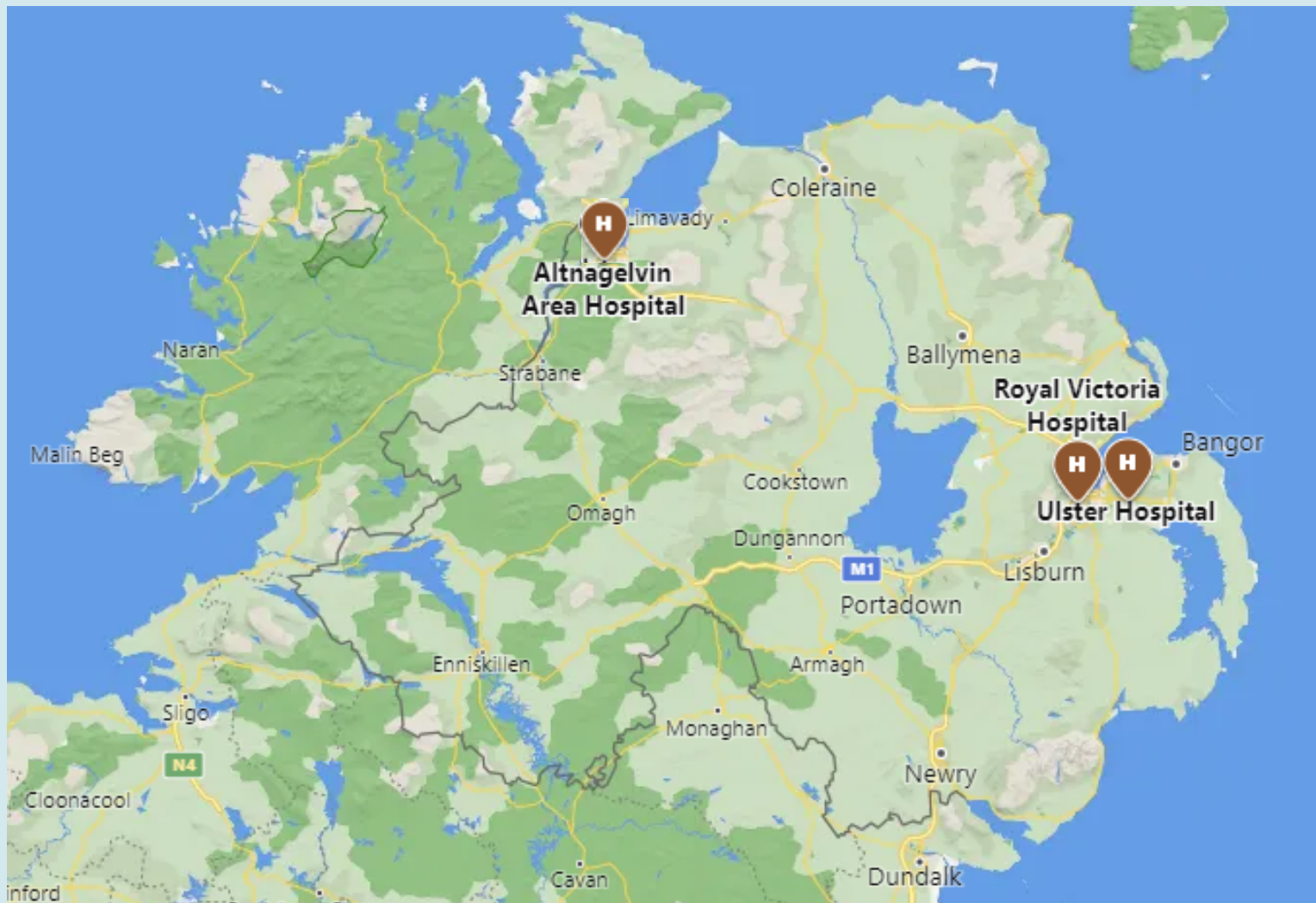
The salary for Dental Core Trainees can be found on the Departmental Circular HSC (TC8) 3/2021 (please note that this pay circular is applicable from 1st April 2021, with the pay award effective from April 2022 still to be applied by the DoH (NI)).

From this pay circular the Pay Scale Code for Dental Core Trainees in Northern Ireland is M230, salary range **£33,133-£37,466**. Actual pay-point on this salary scale for individual DCTs will be advised by the Single Lead Employer Trainee Employment team upon assessment and verification of any creditable previous service.

## ULSTER HOSPITAL

### **DCT1 - Oral and Maxillofacial Surgery/Community Dentistry (1 post)**

The post holder will gain exposure and experience in the delivery of Oral Surgery (OS), Oral Medicine, Oral and Maxillofacial Surgery (OMFS), including head and neck oncology, and Community Dentistry (CDS).

Encouragement and support will be given to attendance at conferences, engagement with audit/Quality Improvement projects and presentations, publications and career planning. A comprehensive DCT Study Programme runs throughout the year.

The post holder will attend new, review and treatment clinics in Oral Surgery, Oral Medicine and Oral and Maxillofacial Surgery. They will also attend the CDS 1 day/week throughout the year. This equates to 25% of the post. The post holder will be expected to travel on a weekly basis to out-patient clinics at peripheral hospitals: Antrim Area Hospital, Craigavon Area Hospital and peripheral Community Dental Clinics.

The post holder will attend inpatient and day surgery theatre lists. This includes assisting and operating on oral surgery GA lists, community GA lists and assisting with head and neck oncology and facial deformity surgery. They will be involved in the ward management of OMFS inpatients as part of a wider team. This post has a 1 in 6 on-call commitment covering trauma (including dental trauma), uncontrolled bleeding and spreading infection. There will always be support available from senior staff and consultants.

## **DCT1/DCT2 Two-Year Longitudinal DCT1 and DCT2 Combined (1 post)**

**Year 1 will be based as a DCT1 in Oral and Maxillofacial Surgery in the Ulster Hospital.**

**Year 2 will be based as a DCT2 in Oral and Maxillofacial Surgery in Altnagelvin Area Hospital.**

In year 1 of this longitudinal post the DCT will gain exposure and experience in the delivery of Oral Surgery, Oral Medicine and Oral and Maxillofacial Surgery including head and neck oncology in the Ulster Hospital.

Encouragement and support will be given to attendance at conferences, engagement with audit/Quality Improvement projects and presentations, publications and career planning. A comprehensive DCT Study Programme runs throughout the year.

The post holder will attend new, review and treatment clinics in Oral Surgery, Oral Medicine and Oral and Maxillofacial Surgery. They will be expected to travel on a weekly basis to out-patient clinics at peripheral hospitals: Antrim Area Hospital and Craigavon Area Hospital.

The post holder will attend inpatient and day surgery theatre lists. This includes assisting and operating on an oral surgery list as well as assisting with head and neck oncology and facial deformity surgery. They will be involved in the ward management of OMFS inpatients as part of a wider team.

In year 2 of this longitudinal post, the DCT2, will gain further exposure and experience in the delivery of Oral Surgery, Oral Medicine, Oral and Maxillofacial Surgery and Orthodontics in Altnagelvin Area Hospital.

Encouragement and support will be given to attendance at conferences, audit project presentation, publications and career planning.

The post holder will attend new, review and treatment clinics in Oral Surgery, Oral Medicine and Oral and Maxillofacial Surgery. They will also attend inpatient and day surgery theatre lists. The post will include further exposure to oral surgery and facial deformity surgery, cutaneous malignant surgery and orthodontics. They will be involved in the ward management of OMFS in-patients as part of a wider team.

There is a 1 in 7 on-call commitment with this post and accommodation is provided. On-call commitment involves covering trauma (including dental trauma), uncontrolled bleeding and spreading infection.

On commencement of post, the post holder must have full registration with the Irish Dental Council in addition to their GDC registration as they will be expected to travel on a weekly basis to peripheral hospitals including Letterkenny, Causeway and Tyrone County Hospitals.
